# Introduction

The Nigerian Association of Evaluators (NAE) is the umbrella body coordinating organ for all Monitoring and Evaluation (M&E) Associations and individual consultants in Nigeria. The Association is dedicated to the advancement of professional evaluation practice and use in terms of knowledge and techniques according to international best practices. Its primary aim is to advance professional evaluation practice in Nigeria and also essentially to interact with international evaluation bodies with a focus on learning and dissemination of knowledge.

The NAE is non-partisan and not in any way involved in, or supports any activity deemed to have partisan political connotation. It is a non-profit, non-governmental legal entity and this, exempts it from any form of control by individuals, government and other agencies beyond that which is allowed by the Companies and Allied Matters Act 1990, Part C.

The NAE is a product of a strong collaboration between the National Monitoring and Evaluation office of the Federal Ministry of Budget and Planning (MBNP), United Nations International Children's Emergency Fund (UNICEF) and the United Nations' Population Fund (UNFPA). The financial and technical support of these partners, ensured the actualization of the Association, which became fully registered with the Corporate Affairs Commission (C.A.C) in 2018 with an interim Executive Council that steered the operations of the association until the election of the substantive executive council in 2019.

## **Vision**

An inclusive, equitable, diverse and credible Association that promotes professionalism, institutionalization, in the research, practice, training and use of evaluation in Nigeria.

## **Mission**

To develop, promote and advocate professionalism, in the practice and use of monitoring and evaluation through collaboration with stakeholders and likeminded individuals within the country and globally to build a community of professional and responsible evaluators and practitioners in Nigeria.

## **Aims and Objectives:**

1. Provide an umbrella platform for individual evaluators and communities of evaluators for strengthening the professionalization of evaluation practice in Nigeria.
2. Establish and maintain partnerships, cooperation, collaboration and/or affiliation with international evaluation organizations and agencies interested in Evaluation.
3. Build consensus on and promote a code of ethics and standards for evaluation practice in Nigeria in compliance with International best practice.
4. Support evaluation research and studies that build the knowledge base and inform policy and practice.
5. Advocate for evaluation demand and proper use, development and practice in Nigeria, through institutionalization of a culture of evaluation in public, private and civil society organizations.
6. Provide a coordinating and regulatory body for evaluation practitioners in Nigeria.

## **ASSOCIATION ACTIVITIES' REPORT**

### **2019 Annual General Meeting: Election and Inauguration of the 1st NAE Executive Council.**

The 3rd Annual General Meeting of the Nigerian Association of Evaluators held at the Rockview Hotel, Royale, Abuja, on Monday 25th March 2019. In attendance were the Association's Board of Trustees (BOT), Election Committee, Australian Evaluation Association, UNICEF, UNDP, World Bank and financial members of the Nigerian Association of Evaluators.

The meeting was presided over by the Chairman, NAE Board of Trustees - former Minister of Budget and National Planning, Dr. Shamsuddeen Usman, CON. Dr. Zakari Lawal - the Director, National Monitoring & Evaluation Department of the Ministry of Budget & National Planning provided insight on the need to bridge the gap and amalgamate all existing Monitoring and Evaluation Associations in Nigeria under one umbrella Association as well as recognized the role played by development partners in the actualization of the NAE. According to him, the discordant manner of operations of several M&E Associations in Nigeria prompted the ministry to convene an all stakeholders meeting for discussion on the need to have an umbrella body that will professionally and coordinate the activities of M&E in Nigeria.

Mallam Aliyu Aminu Ahmed, out-going Interim President, also gave an overview of the Association's activities since inception and appreciated all stakeholders for their efforts in establishing the NAE

the CEEP aims to ensure that emerging trends in Monitoring and Evaluation are clearly communicated to members.

The CEEP is a one-hour weekly discussion session via the ZOOM platform and facilitated by experienced members of the NAE. It held every Friday from 8-9 pm for 11 weeks. The first phase of the CEEP has been concluded and the second phase will commence soonest. However, the Executive are reviewing the first phase in order to ensure the lapses encountered during the first phase are corrected.

## **NAE 2020 Webinar**

The CEEP organized a webinar titled, 'Current Evaluation Practices: Recommendations for country-led Evaluation During and After Covid-19 Pandemic Experience'. Three renowned evaluators were invited as speakers on the programme. They were:

1. Dr. Zakari Lawal, MNI FNAE Director, National Monitoring & Evaluation Department, Federal Ministry of Finance, Budgeting & National Planning, Nigeria.
2. Dr. Elizabeth Dyke, University Council Member, Amref International University and Board Member, Canada Feed the Children.
3. Dr. Florence Ettah, FNAE, 6th President, African Evaluation Association and Principal Consultant GRAIDE International Ltd, Nigeria.

The moderator of the event was the President, Nigerian Association of Evaluators, Dr Uzodinma Adirieje.

The goals of the webinar were to ascertain the following:

1. The existing evaluation policies for Covid-19 pandemic in Nigeria and other countries.
2. Efforts put in place to evaluate the various phases of impact of the pandemic.
3. The level of partnership existing between government and CSOs in carrying out independent evaluation of the impact of the pandemic with a view to planning for post Covid-19 interventions in different countries.

The programme attracted about 200 participants globally and they were actively involved in the proceedings.

## **Response to Covid 19 Pandemic**

The Continuing Education on Evaluation Programme (CEEP) prepared a comprehensive summary of the speech of the Honourable Minister of Finance, Budget and National Planning, and Chairperson of

National Fiscal Measures Committee in response to covid-19 pandemic and oil price fiscal shock. This summary was presented at the inaugural meeting of the NAE Technical Support Team in May 2020 as baseline information towards the proposed partnership between the Ministry of Finance, Budgeting and National Planning and the Nigerian Association of Evaluators in charting a national COVID 19 focused evaluation strategy for Nigeria.

## **International Organization for Cooperation in Evaluation (IOCE) Membership**

The NAE became a Voluntary Organization of Professional Evaluators (VOPE) member of the International Organization for Cooperation in Evaluation (OICE) in June 2019. The goals of VOPEs include supporting the professionalization of individual evaluators; contributing to the capacity of organizations to design, request, appreciate, and use evaluations; actively promoting evaluation as a decision-making, sense-making, and learning tool within national public policy and programming systems.

It is believed that the NAE will benefit from this membership as it plays an important role in helping governments and civil society in their countries to understand what evaluation is, and the role evaluation can play in supporting better informed public policy and decision making.

## **Central Organizing Committee for the 2020 International Conference**

The National President Dr. Uzodinma Adirieje had inaugurated the Planning/Organizing Committee for the 2020 International Evaluation Conference. Member of the committee will consist of members of the Association in good financial standing with the Association.
